TROLLEY RESTRICTIONS & TERMS:

- Maximum seating capacity on the trolley is 22.
- The trolley is limited to use in the city limits of McPherson.
- Smoking, alcoholic beverages, illegal drugs and food are prohibited on the trolley; bottled water is permitted.
- All passengers must remain seated at all times.
- Decorating the trolley is prohibited
- The client assumes responsibility for any overtime charges and authorizes the McPherson Convention and Visitors Bureau to provide an invoice for related overtime fees.
- The McPherson and Conventions Bureau is not responsible for lost or stolen items during the use of the trolley.
- The client assumes responsibility for any and all damages caused by either the client or the client's guests whether by accident, neglect or intent during the time the trolley is occupied. A mutual inspection by the trolley driver/trolley guide and a charter representative will be made to determine the condition of the trolley before and after the rental. It is the responsibility of the chartering party to insist upon these inspections.
- A full refund of the rental fee will be made if the McPherson Convention and Visitors Bureau has to cancel the trolley rental due to road conditions, weather or mechanical failure.
